

**Public Participation**

The City of Glendale conducted its public hearings before the Community Development Advisory Committee (CDAC), which is responsible for reviewing the CDBG, ESG, and HOME application funding requests, and for making funding recommendations to the Mayor and City Council. Funding recommendations made by the CDAC were based upon the needs of the community. Public hearings were conducted at convenient times and locations and Spanish-speaking interpreters were available upon request, as well as special accommodations for persons with disabilities. One public notice was published in English announcing the date, time, and location of the public hearings (published December 17, December 24, and December 31, 2009). The notices were published in a local newspaper of general circulation, The Glendale Star.

In an effort to further encourage public participation, a public notice was published for three consecutive weeks in The Glendale Star (March 11, 18, and 25, 2010), which provided citizens with a summary of the proposed Program Year 5 Annual Action Plan, and information regarding the thirty-day citizen review and comment period.

Draft copies of the proposed FY 2010-2011 Program Year 1 Annual Action Plan (AAP) and the FY 2010-2014 Five-Year Consolidated Plan were made available for public review and comment from March 26, 2010 through April 26, 2010, on the Community Revitalization’s web page at
