Failure to provide a birth certificate or religious document (baptismal record) will result in that participant being ineligible to compete. • **Participants may compete in only ONE local event.** • Score results will be posted within 48 hours of each competition at GlendaleAz.com/ParksAndRecreation. • Winners will be notified by phone.
